Individual Consultants employed by Firms' may express interest through the Firm for the assignment and, under such situation, only the experience and qualifications of the Consultant shall be considered in the selection process. The criteria for selecting the Consultant are:

1. Relevant tertiary qualification (s);
2. Minimum 10 years' experience in research and evaluation at a senior level;
3. Excellent capabilities in analysis, data collection, stakeholder liaison and report-writing;
4. Strong command of written and spoken English;
5. Proven ability to work independently, to be self-motivated, dynamic, and comfortable in ambiguity;
6. Experience with similar assignments, preferably in Samoa and/or the Pacific.

The successful consultant must have current Samoan business licence, or obtain one prior to commencement of the assignment, in accordance with the Business Licence Act 1998.
