RECONSTRUCTION OF THE MAOTA FONO PODIUM AND ASSOCIATED SITEWORKS AT THE SAMOA PARLIAMENTARY COMPLEX, MULINU'U

The Government of Samoa, represented by the Office of the Clerk of the Legislative Assembly, has received grant funds from the Commonwealth of Australia for the construction of a new Maota Fono (Parliament House), and associated site and ancillary works (collectively known as the Samoa Parliamentary Complex Redevelopment Project).

The Office of the Clerk of the Legislative Assembly requests proposals from eligible and experienced **Contractors registered in Category A (works above SAT 1.5M) with the Ministry of Works, Transport and Infrastructure** for the provision of Construction (Works) Services for the Maota Fono Site Works and Podium Reconstruction at Mulinu'u, in accordance with the bidding documents.

1. Broadly, the Works encompass, but are not limited to:

- 1.1 Demolition and reconstruction of the Maota Fono podium slab, walls and ceremonial steps;
- 1.2 Construction of Porte coche, new vehicle and pedestrian podium access ramps and steps.
- 1.3 Construction of new ancillary site works including bus layby, accessible toilets, generator plinth, overflow carpark.
- 1.4 Relocation of existing Services.

Interested Contractors may register their interest on **Monday 13th November 2023** and obtain the bidding documents free of charge from the Office of the Clerk of the Legislative Assembly home menu link on: www.palemene.ws and the Government of Samoa ('GoS') e-Tendering portal on https://portal.tenderlink.com/mof_samoa/

Tenders must be submitted in the requisite format in accordance with the Bidding documents on or before **11.00am (Samoa time) on Monday 18th December 2023** to the address below. Late tenders will be rejected and shall be returned to the bidder unopened. Tenders will be opened in the presence of the Tenderers or Tenderer's Representatives (and also in the presence of representatives of the procuring entity) at the address below and commencing from **11:30 AM ON THE SAME DAY** the Tenders are closed and opened by the Government Tenders Board.
